COVID-19 Small Business Assistance Grant Application

In response to the adverse economic impact of the COVID-19 pandemic, the Yorktown Economic Development Corporation (YEDC) is offering financial assistance to those affected through COVID-19 mandates of operating their business and loss of revenue. A COVID-19 Small Business Assistance Grant is presented for businesses with a Yorktown address that is a full-time operating business and have been significantly impacted by this pandemic.

This grant focuses on monthly expenses to assist in recovering loss due to the pandemic government mandates. Non-home-based **full-time** small businesses are qualified to apply to include retail (storefront), restaurant/food business; personal care products (barber shop, salons, etc.); and other non-essential business operators that were operating prior to the pandemic. The Small Business Assistance Grant is intended to reimburse the applicant for a portion of the applicant's utility billing minus fees and taxes, rental payments, business loan installments that are a standard routine of monthly expenses. A maximum of \$1200 is available per business applicant for expenses from March through May 2020. Recipients will be determined by the YEDC Board of Directors.

Businesses must meet the following criteria:
